#### **GUIDELINES**

To ensure the best experience, please note the following:

- Please bring your own drinking water and label your bottle(s).
- Please dress modestly. If you plan to join our children in the pool, we ask you wear a modest swimsuit (one-piece preferred) and bring a personal towel to use.
- Do not give the children food or gifts. All such things must be approved by the directors.
- Foul language, drinking and smoking are not allowed at anytime.
- Do not allow the children to hold your phone, camera or other expensive items.
- If you plan to do projects, many involve painting so please wear appropriate clothing and shoes.
- We are not an adoption agency; many of our children are not available for adoption. If you desire
  information on adopting from Jamaica, please contact the Child Protection and Family Services Agency
  (http://childprotection.gov.jm/).
- Do not make any comments to the children about bringing them home or make promises to come back.

### **FOOD**

All day teams are required to bring their own lunch the day of their volunteer service to ensure the Nest cooks can focus on preparing meals for the children we serve.

## **CONFIDENTIALITY AGREEMENT**
